We welcome the growing feeling of constructive engagement with the Gloucestershire Hospitals NHS Foundation Trust. Its new Chief Executive, Deborah Lee, responds promptly to concerns raised by this office and in particular is taking steps to avoid the 'patient ping-pong' currently initiated by letters from the e-referral system that tell patients to contact their GP if an appointment is not available.

e-referrals

However, the problem has not yet gone away: patients are still being told by 'the system', when an appointment is not available to meet an e-referral, to contact their GP. This is helpful neither to the patient (since the practice can do nothing except ring the hospital on their behalf) nor to the practice (because of the extra work involved). You may therefore find the leaflet and the template letter to be found at:

Indemnity

The GPC is working very hard with other organisations to:

- Settle a winter scheme for OOHs doctors. We understand that details have been agreed and will be published shortly.
- Address the wider issue of the Discount Rate. This is arguably much more important if not immediately pressing. It is likely to be a difficult negotiation.

As soon as we get any firm information we will pass it on. In the meantime, GPs should avoid any work for which they lack indemnity cover.

Mandatory training

Cyber attack and the Extended Hours DES

For the avoidance of doubt, any hours in which a practice is unable to fulfil its Extended Hours DES commitments as a result of cyber attack, rather than its own decision, will not count as missed hours for the purposes of payment for the DES

NHS SBS aftershocks

You will recall that under NHS Shared Business Services some correspondence in the mail redirection service did not reach the intended recipients. The incident team sent correspondence to GP practices in December 2016, March and May 2017 asking practices to complete and return a response form to indicate whether any patient may have suffered potential harm as a result of the error. About a third of practices have yet to return these

forms. NHS England will be writing to Heads of Primary Care to inform them of practices that have yet to respond, and CCGs will also be aware.

The GPC would encourage practices to undertake this in a timely manner practices are best placed to do it, and should be paid for such work. Payments for work undertaken in March and May 2017 will be paid in August or September 2017.

All cases of potential harm are now being reviewed by NHS England GP national Clinical Directors to confirm whether further clinical review is required. NHS England are contacting practices to obtain patient details, and can offer support to practices if required. In recognition of workload on practices, local area teams may be asked to assist with providing information.

NHS England has provided GPs with a dedicated phone line 0800 028 9723 and email address <u>england.sbsincident@nhs.net</u> on which they can use to contact the Incident Team with any queries.

Changes to patient registration requirements

From 2 October 2017, GPs will need to complete all new patient registrations using the new family doctor services registration (GMS1) form. The revised GMS1 form contains the same information as the current GMS1 form, as well as a supplementary questions section for overseas patients. Copies of the new form will be delivered directly to GP practices ahead of the 2 October 2017 date. Should any practice require further forms after that delivery, please order these from the primary care service England portal. The form can also be downloaded from the <u>NHS Choices</u> website.

Another scam

Reported from elsewhere in the country: "a man attempted to gain bank details of sessional GPs. The man called himself James Keith and phoned the practice reception team stating the name of the Doctor working there and claiming that he worked for a locum agency "down south" but their systems were down so they needed the doctors bank account details so they could pay them. The practices involved did not give out any details and the attempted crime has since been reported to the Action Fraud Team and the police are dealing with it."
